

NEZ Formula Ford

Regulations 2010

1. CUP

This is regulations for:

North European Zone Formula Ford CUP

Short: NEZ FF Cup.

2. Title and Jurisdiction

The 2010 NEZ FF Cup is handled by the NEZ Racing Commission in association with the respective countries Circuit racing committees or their representatives in the FIA North European Zone. The entrants are enforced to follow the General Sporting Regulations from each ASNs and Organizing Club's.

Competitors must ensure that their cars comply with the conditions of eligibility and safety throughout qualifying and racing.

NEZ Racing Commission representatives together as a voting body has the right to grant some racing vehicles with additional technical requirements.

3. Eligible Drivers

The Events will be National, (NEAFP permitted) and are open to drivers with an appropriate, valid driver's license, including racing permission from their respective ASN.

Only drivers with a license issued of a NEZ-country can score points in the Championship.

4. Eligible Cars

Cars must fulfill requirements of MSA Technical Regulations for Formula Ford (Zetec and Duratec).

Noise level according each event Supplementary Regulations.

6. Results

The points will be given on one classes Formula Ford.

Drivers who pass scrutinizing and participate in the timed practice will be counted as having started.

Points will be awarded to Competitors listed as classified race finishers (completed at least 75 % of race distance) in the results for each race according to the following scale.

Fastest qualifying lap 1 point.

Fastest lap each race 1 point.

All starts will be added to determine the overall results of the NEZ series.

If General Rules does not split drivers with equal points, the following will apply: The final order of drivers who scored equal points will be determined based on the order the respective drivers finished in the last race.

7. Entries

Competitors are responsible for sending in correct and complete entries to the entry closing date to the event organizer.

8. Race Numbers and advertising

Each formula will carry the race number of its driver. Competition numbers will be given by the secretary of the event. The figures of the competition numbers shall be black on a white rectangular background.

9. Free Practice, Qualifying and Race

According to each event-organizer's time schedule. 2 races - weekend (event) with a distance of 25 to 50 km per race. Qualification according each event Supplementary Regulations. False start will be penalized according each event Supplementary Regulations.

10. Fuel

According to supplementary regulations of the event.
In Finland, bioethanol E85 is also allowed.

Only Zetek can use bioethanol E85 fuel

11. Tyre Limitation

According to supplementary regulations of the event.

12. Time-keeping

All competitors must have their own or rented time-keeping transponder mounted and working when the car is on the track (free practice, qualifying and race).
